**REGULATIONS PERTAINING TO CLAIMS TO SCHOLARSHIPS FROM HPBoSE**

- (a) Any claim to the Scholarship shall be regulated by the provisions of the scheme in force at the time when the Trust decides to award a scholarship to the needy/meritorious student(s).
- (b) The scholarship given under this scheme shall be in addition to the scholarship paid by Board under the provisions of chapter 15 of the H.P. Board of School Education Examination Regulation, 1994.
- (c) The rates of Scholarship are as under:-

Sr. no.	Name of the examination Passed	Rate of Scholarship
1	Matriculation Examination	Rs. 2700/- Per annum
2	10+2 Examination	Rs. 3000/- Per annum

- (d) The duration of the scholarship shall be 1 year i.e. the scholarship shall be paid once only.
- (e) The candidates whose family income from all sources is up to Rs.1, 00,000/- Per annum shall be eligible for this scholarship. For each category of needy and meritorious students 90% scholarship shall be earmarked on the basis of merit and family income.
- (f) 10% scholarship would be earmarked for differently-abled candidates (deaf, mute, blind and disabled) with at least 40% disability who have appeared and passed one of the Examination mentioned at (c) above, in second division or above.
- (g) The eligibility of the candidate entitled to get benefit under the scheme will be based on the Annual income of his family and the percentage of Marks obtained. Both the conditions of Annual Income and percentage of Marks will carry credit of 10 marks each. The criteria of allotment of marks will be as under:

- a. **Differently-abled candidates having secured 50% to 64% and above marks:**

(i) Total number of annual Scholarship is 14 each for Matriculation and Plus Two Exam. The number of Scholarship may be increased or decreased by the Trust.

**(j) CANCELLATION OF SCHOLARSHIP:**

In case on an inquiry it is found that any student/guardian has furnished false information to obtain the scholarship, the scholarship shall be cancelled and the amount, if any, disbursed to the student by way of this scholarship shall be recovered from the student/parent/guardian along with interest at the rate of 15% per annum
