for AMC of EPBAX of H.P. Board of School Education

- 1. The tender form can be had from the Section Officer, Store Branch of the Board on any working day upto 12:00 noon against the payment of Rs. 1000/- or downloaded from the website of the board- "www.hpbose.org" accompanied with DD worth Rs. 1000/- payable to the Secretary H.P. Board of School Education. Tenders without Tender fee shall be rejected.
- 2. The Tender form containing duly filled in enclosed proforma I & II shall contain:
 - a) Copy of PAN, Service Tax Number and TIN/GST number.
 - b) Copy of authorization certificate for the repair and maintenance of EPBAX. If the tenderer is an authorized representative of a service provider.
 - c) Detail of Service Engineers with proof of their qualification.
