

Subject: Implementation of "Central Sector Scheme of Scholarship for College and University Students" through the National Scholarship Portal 2.0 for the Academic Year 2017.

Madam/Sir,


In continuation of the Department of Higher Education's letter of even number dated 28.7.2017 (copy enclosed) wherein the State Education Boards were informed about the National Scholarship Portal becoming live from 18.7.2017 in respect of the "Central Sector Scheme of Scholarship for College and University Students". The last date for online application for Fresh 2017 is 31.10.2017 and for renewals is 30.9.2017.

2. On going through the status of online application, it is seen that very few students have applied online under the scheme. Reason for poor response could possibly be due to lack of awareness amongst the target group. To bring awareness, it is requested that the State Education Boards, may prominently display the information about the online application on their website, and also bring out advertisement in the regional dailies, the expenditure towards which can be met from "Administrative Expenses". A specimen copy of the "Public Notice" in this regard is enclosed at ANNEXURE-I.

3. In view of the above, it is requested that the matter may be looked into and necessary directions be given to the designated Nodal Officer. Action taken in this regard may kindly be sent to the Department, which would be highly appreciated.
