CET-2026) on dated 31.05.2026 for admission to the Two-Year Diploma in Elementary Education (D.El.Ed.) course for the academic session 2026-2028. In this regard, online applications are hereby invited from eligible candidates. Candidates shall deposit the prescribed fee through Debit Card/Credit Card/Net Banking by accessing the Payment Gateway link available in the online application. No fee shall be accepted through any other mode. The Board shall provide an opportunity to candidates to rectify errors in their application details during the prescribed correction period. Candidates may make such corrections online only within the stipulated dates. However, no corrections shall be permitted online in respect of category and sub-category, as the same has a bearing on the applicable application fee. In case a candidate seeks correction in category or sub-category, he/she shall apply offline to the Board office within the prescribed period, along with supporting documentary proof of the relevant category/sub-category. No requests, representations, or communications received through post, email, or any other mode after the expiry of the stipulated period shall be entertained. 
