अधिसूचित किया जाता है कि हिमाचल प्रदेश स्कूल शिक्षा बोर्ड अधिनियम 1968 की धारा 19(3) में निहित शक्तियों का प्रयोग करते हुए अध्यक्ष, हिमाचल प्रदेश स्कूल शिक्षा बोर्ड द्वारा वर्तमान में हिमाचल प्रदेश राज्य मुक्त विद्यालय के तहत प्रचलित प्रायोगिक परीक्षा के नियम में निम्न प्रकार से संशोधन करने के सहर्ष आदेश प्रदान करते हैं :-

3.13	The Practical Examination will be conducted at the same Study Centre, the days and dates are decided by the HPSOS in the date sheet. The Practical Exam Centre will be the concerned of Study Centre provided the Minimum twenty learners should be available for organizing for Practical Exam. In case of non-availability of Study Centre, with the approval of the Chairman of HP BOSE, nearest Study Centre of HPSOS or Examination Centre of HPSOS may be fixed for Practical Examination Centre as a special case. The Practical Examination for Vocational Subjects under academic stream will also be conducted at the respective	3.13 I. The Practical exam shall be conducted only in the HPSOS Study Centre from where candidate has applied or filled his/her online admission form, the days and dates will be decided by the HPBOSE in the date sheet. II. The practical exam under HPSOS will be conducted only after the completions of theory examinations or as decided /notified by the HPBOSE. III. In special circumstances, the practical exam can also be conducted pre or post of the theory examination. IV. The blind examinees have been exempted from taking practical examination. V. The HPSOS Study centres having affiliation only upto the high School will make arrangements for the 10+2 class practical subjects exams in their own SOS Study centre /nearest school. VI. It is mandatory to appear in practical as well as in theory portion of the practical involving subject in the same examination session. VII. If a candidate fails in practical examination but pass

study centre. The candidates may approach their respective study centres for details of Practical Examination.

in the theory examination, in that case candidate shall have to appear in both theory as well as practical examinations in upcoming examination session.

- VIII. Those candidates who have changed their SOS Study Centre/Examination centres they also have to appear from their latest SOS Study Centre/Examination Centre for the practical examination.
- IX. The concerned SOS study centre will fill/upload the marks obtained by candidates in their practical examination in the online portal provided by the board.
- X. After filing/uploading the marks of candidates in the online portal, the concerned SOS study centre will ensure to send the same original award mark list of the candidates to the board office at the scheduled time only.
- XI. The TOC facility in practical subject (if failed in theory exam but passed in practical exam only) for the candidates of other recognized boards shall not be allowed, it will be mandatory to appear in practical.
- XII. Those candidates who have already passed (HPBOSE/HPSOS Candidates only) the practical examination and if such candidates appears again for the practical examination under HPSOS, in this case, the highest marks will be considered between the earlier obtained old marks and latest new marks.
- XIII. In case, the marks of a candidate in a subject (Theory & Practical) is found to be greater than the maximum

of marks assigned under the Scheme of Examination of HPSOS, then the earlier marks obtained by the candidate in that particular subject (Theory & Practical) shall be converted on the basis of proportionate to give the benefit of TOC.
