### **NOTIFICATION**

It is hereby notified that, in accordance with the policy framed and notified by the Government of Himachal Pradesh, the Directorate of Education, Himachal Pradesh shall determine the eligibility, suitability and deputation of in-service teachers to Himachal Pradesh Government Schools affiliated with the Central Board of Secondary Education (CBSE) and the CBSE Sub-Cadre thereof.

Accordingly, as per the directions of the Directorate of School Education, Himachal Pradesh, the Himachal Pradesh Board of School Education (HPBoSE) shall conduct the Screening Test for Deputation to CBSE Sub-Cadre – 2026 against 5,623 posts (for 134 CBSE affiliated schools) from amongst in-service teachers working in the establishment of the Directorate of School Education, Government of Himachal Pradesh, who fulfil the requisite educational qualifications and eligibility conditions as prescribed under the applicable Recruitment and Promotion (R&P) Rules. The role of HPBoSE shall be confined strictly to the conduct of the screening test, preparation of post-wise merit lists and declaration of results, whereas all matters relating to eligibility, deputation, posting and service conditions shall vest with the Directorate of School Education, Himachal Pradesh. The online applications are invited from eligible applicants for this recruitment/examination. The detail of posts are as follows:

Further, submission of an online application shall not confer any right of participation, selection or deputation, which shall remain subject to post wise merit list in aforesaid screening test, scrutiny of eligibility, verification of documents, availability of posts, and approval of the competent/Appointing Authority.

Candidates shall deposit the prescribed examination fee only through Debit Card / Credit Card / Net Banking by accessing the Payment Gateway link provided in the online application system. No fee shall be accepted through any other mode and applications submitted without successful payment of the prescribed fee shall be treated as invalid and rejected outright.

The Board Office shall provide a one-time opportunity to candidates to rectify errors in their submitted online application forms. Such corrections shall be permissible only during the notified correction period and on the prescribed dates, and no request for correction shall be entertained before or after the said period. The responsibility for ensuring the accuracy of all particulars furnished in the application shall rest solely with the candidate.
