**Notification**

It is hereby notified for the information of all concerned that the Himachal Pradesh Board of School Education (HPBOSE) has successfully conducted the Special Marks Improvement Examination of the Himachal Pradesh State Open School (HPSOS) in September 2025 for Classes 10<sup>th</sup> and 12<sup>th</sup>.

The results of the aforesaid classes have been formally declared on 08<sup>th</sup> January 2026. Candidate details are recorded under the following categories:

Candidates interested in applying for Re-checking are required to submit their online applications exclusively through their respective HPSOS Study Centres on or before 23.01.2026. The prescribed fee is as follows:

- Re-checking: ₹ 800 per subject

It is also notified that the concerned HPSOS study centres shall submit the old certificates of candidates whose results have been positively revised (PRC) in the Improvement Examination to the Board's office. This is required to ensure proper verification and record keeping.

All such certificates must be submitted within one month from the date of declaration of the result. After the expiry of this period, new certificates will be issued only upon payment of the prescribed financial penalty.
