Sealed bids alongwith earnest money in the form of Demand Draft should reach in the office of the Secretary, HP Board of School Education, Dharamshala (Store-II Branch) by 22-12-2023 upto 11.00 AM which will be opened on the same day at 02.00(PM)

TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLE

1. The Secretary, HP Board of School Education, Dharamshala intends to dispose of condemned vehicle on "as is where is basis".
2. Tender document pertaining to the auction of vehicle can either be downloaded from the board's website www.hpbose.org which shall be accompanied with the processing fee in the form of a demand draft amounting to ₹1000/- (₹One Thousand Only) drawn in favour of the Secretary, H.P. Board of School Education, Dharamshala or can be obtained from the office of the Secretary, HP Board of School Education, Dharamshala by depositing processing fees of ₹1000/- (₹One Thousand Only) on any working day from 10:00am to 03:00pm.
3. Interested Parties may submit their highest prices for the condemned vehicle as mentioned in auction notice in sealed covers latest by 11.00 AM on or before ~~22-12~~ 22-12-2023. The envelope containing quotations and other relevant documents alongwith Demand Draft towards EMD should be sealed properly. Sealed quotations may be submitted in the office of the Secretary, HP Board of School Education, Dharamshala (Store-II Branch). The outer cover should be superscribed in bold letters "Quotations for auction of vehicle No. HP39B0099.
4. The disposal of vehicle shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by the Board. The condition of the vehicle can be inspected physically between ~~4-12~~ 4-12-2023 to ~~21-12~~ 21-12-2023 at the office, HP Board of School Education, Dharamshala
5. The quotation should be accompanied by earnest money for ₹20,000/- for the vehicle in the form of Bank Demand Draft only drawn in favour of the Secretary, HP Board of School Education, Dharamshala. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest bidder/successful bidder fails to deposit the sale price within 03 days positively, his earnest money will be forfeited. In case the offer is withdrawn by any bidder, the earnest money deposited by him shall also be forfeited.
6. The successful bidder will be required to deposit the total bid amount by means of Demand Draft in favour of the Secretary, HP Board of School Education, Dharamshala within three working days of award of bid.
7. EMD of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by the Board.
8. EMD amount of the successful bidder will be adjusted in the Sale Amount.
9. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Aadhar Card in case of individual and Registration Certificate in case of firms etc.)

10. The sold vehicle will be removed by the successful bidder within 48 hours of depositing the money at their own expenses. No assistance/transportation will be provided by the Board. Permission to take out disposed vehicle from the aforesaid premises will not be allowed on Govt. holiday and Sunday.
11. The successful bidder(s) will also be responsible for getting the Registration Certificate of the vehicle(s) transferred in his/her name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
12. The present registration number of the vehicle shall be retained by the Board and will not be transferred to the bidder. The highest bidder / the bidder who has been awarded the bid shall have to apply for new registration number for the vehicle as per the due procedure and process under the rules Motor Vehicles Act, 1988 at his cost only.
13. The Secretary, HP Board of School Education, Dharamshala reserves the right to reject any or all of the bids without assigning any reason(s) whatsoever.
14. The bid amount is excluding GST, as the GST on the offered price will be charged at the prevailing rates.
15. EMD of unsuccessful bidders i.e. the same draft shall be returned within a week of auction of the vehicle.
16. The bidders are required to reveal their full name / name of the authorized signatory of the firm/ name of father, full postal address, telephone number & mobile number.
17. Disputes, if any, shall be subject to jurisdiction in the Court of Dharamshala only.
18. If the highest quoting firm fails to honour the bid: the bid will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of the Secretary, HP Board of School Education, Dharamshala shall be final.
19. Tender form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations(s) shall be rejected.
20. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
21. Quotations should be offered in proforma prescribed as given at Annexure-A.
