Term & Conditions
for AMC of Photostat Machine of H.P. Board of School Education

1. The tender form can be had from the Section Officer, Store Branch of the Board on any working day up to 03:00 pm or downloaded from the website of the board- www.hpbose.org.
2. **The Tender form should be accompanied with Earnest Money Deposit (EMD) equal to 10% of the Contractual amount in the form of FDR duly pledged / payable to the Secretary H.P. Board of School Education. The EMD of the successful bidder shall be converted in performance security whereas the EMD of unsuccessful bidders shall be returned after short listing of the L-1.**
3. Rates quoted should be exclusive of GST.
4. Conditional/ambiguous tenders shall not be accepted. Tenders received after due date and time due to delayed postal delivery or some other reasons shall not be accepted.
5. The rates should be quoted on the prescribed tender form of the Board and in accordance with the terms and conditions as laid down by the Board. All corrections in the tenders form must be signed by the tenderer.
6. One quarterly preventive maintenance of each equipment will be mandatory and in case of trouble shooting there will be no limit of calls for repairs of the equipments.
7. The complaint of the Photostat Machine should be attended within 24 hours positively.
8. In case Machine remains out of order after registering of the complaint in writing for more than two days penalty @ Rs 1,000/- per day will be levied for each complaint and the same will be deducted from the next payment of the contractor.
9. The rates quoted by the tenderer shall not be increased at any cost till the period of the contract.
10. The rate contract shall be initially for a period of one year which can be extended further by mutual consent on the same terms and conditions and subject to satisfactory performance.
11. The Spare Parts, chargeable to the Board, as required from time to time for repair and maintenance of the Photostat Machine along with their rates may be listed in the Annexure-III.
12. TDS shall be deducted as per Income tax law.
13. Technical bids (Annexure-II) and Financial bids [(Annexure III(i) & (ii)] should be sealed in separate envelopes superscribed as "**Technical bid for AMC of Photostat machine**" and "**Financial bid for Photostat machine**" and both these envelopes should be sealed in big envelopes superscribed as "Tender for AMC of Photostat Machine". Financial bids will be opened for technical qualified bidders only.
14. The successful bidder has to enter into agreement with the board authorities within 10 days from the date of the award of the contract.
15. In case of any dispute, the decision of the Chairman, H.P. board of School Education, Dharamshala shall be final and binding on both the parties.
16. All disputes shall be subject to the jurisdiction of Dharamshala court only, if any of the parties is not satisfied with the Chairman decision.
17. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever as well as to cancel the tender process at any stage.
