			If a complaint is proved in the investigation by the enquiry committee, such examination centre will be suspended for the period of one year from the date of notification and security deposit will be forfeited. After completion of one year, such school will have to go through the complete process of centre creation alongwith all requisite fees. (ii) Second time complaint proved:-
			If a complaint is proved in the investigation by the enquiry committee, such examination centre will be suspended for the period of two years from the date of notification and double amount to the security deposit will be imposed as penalty.
