It is hereby notified for the information of all concerned that the **Himachal Pradesh Board of School Education (HPBOSE)** has successfully conducted the **Himachal Pradesh State Open School (HPSOS) Examinations in September 2025** for Classes 8th, 10th and 12th.

The results of the aforesaid classes have been formally declared on 23rd December of 2025. The pass percentage is recorded in the following manner:

Candidates interested in applying for Re-evaluation (Classes 10th and 12th) or Re-checking (Classes 8th, 10th and 12th) are required to submit their online applications exclusively through their respective HPSOS Study Centres on or before **07.01.2026**. The prescribed fee is as follows:

- **Re-evaluation (Classes 10th & 12th):** ₹ 1000 per subject
- **Re-checking (Classes 8th, 10th & 12th):** ₹ 800 per subject

Furthermore, candidates whose result has been declared as **Reappear** or **Pass**, and who wish to apply for the **Reappear or Improvement examination** (within 1 year), may submit their online applications for the March 2026 session exclusively through their respective HPSOS Study Centres between **27.12.2025** and **12.01.2026**, without payment of any late fee.
