हिमाचल प्रदेश स्कूल शिक्षा बोर्ड के पेंशनभोगियों के लिए आवश्यक निर्देश

- (1) **PENSION PAYMENT ORDER -PART-II** के पृष्ठ पीछे दर्ज **IMPORTANT INSTRUCTION** के अनुसार हिमाचल प्रदेश स्कूल शिक्षा बोर्ड के पेंशनभोगी को प्रति वर्ष नवम्बर माह में अपना जीवन प्रमाण पत्र (Life certificate) कार्यालय में उपलब्ध करवाना अनिवार्य है जिसके लिए दिशा-निर्देश निम्न प्रकार से हैं:-

Any person sending a Life Certificate signed by some persons exercising the powers of a Magistrate under the Criminal procedure Code, or by any Registrar or Sub Registrar appointed under the Indian Registration Act, 1908 or by any pensioned officer who, before retirement exercised the powers of a Magistrate or by any Gazetted officer or by a Munsiff or by a Police Officer not below the rank of Sub-Inspector In-charge of a Police station or by a Post Master, a Departmental Sub-Post Master or an Inspector of Post offices, or by officers of the Reserve Bank of India and Public Sector Bank or by the Head of village Panchayat, Gaon Panchayat or Gram Panchayat or by the Head or an executive Committee of a village or by a Bank included in the second schedule to the Reserve Bank of India Act, 1934, in respect of persons drawing pension through that Bank.
